<b>Identification card issued by WI governmental body or unit</b>	<ul style="list-style-type: none"> <li>- Valid on date of registration*</li> </ul>	<b>Military ID card issued by a U.S. Uniformed Service</b>	<ul style="list-style-type: none"> <li>- Unexpired, or expired after 11/8/2022</li> </ul>
<b>Identification card issued by employer (not a business card)</b>	<ul style="list-style-type: none"> <li>- Valid on date of registration*</li> <li>- Photo required</li> </ul>	<b>Military ID card issued to a veteran by a U.S. Uniformed Service.</b>	<ul style="list-style-type: none"> <li>- May be expired—some may indicate “indefinite.”</li> </ul>
<b>Real estate tax bill or receipt</b>	<ul style="list-style-type: none"> <li>- For current year or year preceding date of the election</li> </ul>	<b>Photo ID issued by the federal Dept. of Veterans Affairs</b>	<ul style="list-style-type: none"> <li>- Unexpired or has no expiration date</li> </ul>
<b>Wisconsin University, College or Technical College ID</b>	<ul style="list-style-type: none"> <li>- Photo required – Address not required on ID</li> <li>- Plus fee receipt with address dated within last 9 months</li> <li>OR</li> <li>- the clerk may verify the ID against the certified housing list</li> </ul>	<b>Wisconsin University, College or Technical College ID</b>	<ul style="list-style-type: none"> <li>- May be expired -Date of issuance</li> <li>- Signature of student -Photo required</li> <li>- Expiration date no later than 2 years after date of issuance.</li> <li>- Document that proves enrollment. (not required if ID is unexpired)</li> </ul>
		<b>U.S. Passport booklet or card</b>	<ul style="list-style-type: none"> <li>- Unexpired, or expired after 11/8/2022</li> </ul>
<b>Utility bill (gas, electric, phone, cell phone, cable TV, satellite, internet, garbage)</b>	<ul style="list-style-type: none"> <li>- For period that starts no earlier than 90 days before registration</li> </ul>	<b>Certificate of Naturalization</b>	<ul style="list-style-type: none"> <li>- Unexpired</li> <li>- issued not earlier than 2 years before election</li> </ul>
<b>Bank or Credit Union Statement</b>		<ul style="list-style-type: none"> <li>- Any bank or CU account statement, regardless of the type of account.</li> </ul>	<b>WI DOT Driving Receipt</b>
<b>Credit Card Statement</b>	<ul style="list-style-type: none"> <li>- any credit card statement, including retail</li> </ul>	<b>WI DOT ID Card Receipt</b>	<ul style="list-style-type: none"> <li>- Unexpired - Valid for 45 days</li> </ul>
<b>Paycheck or stub</b>	<ul style="list-style-type: none"> <li>- None</li> </ul>	<b>Citation or Notice to Revoke or Suspend WI Driver License</b>	<ul style="list-style-type: none"> <li>- Unexpired</li> <li>- Dated within 60 days of the election</li> </ul>
<b>Check or other document issued by a unit of government</b>	<ul style="list-style-type: none"> <li>- Valid on date of registration*</li> </ul>	<b>IDPP receipt</b>	<ul style="list-style-type: none"> <li>- Unexpired, valid for 60 days.</li> </ul>
<b>Residential Lease</b>	<ul style="list-style-type: none"> <li>- Effective on date of registration*</li> <li>- Cannot be used as POR when registering by mail.</li> </ul>	<b>ID card issued by federally recognized WI tribe</b>	<ul style="list-style-type: none"> <li>- Expired or unexpired</li> </ul>
<b>Care Facility Contract or Intake Document</b>	<ul style="list-style-type: none"> <li>- Must indicate voter resides at facility</li> <li>- Is not required to indicate room number</li> </ul>	Proof of Identification documents do not have to list a current address to be valid.
