June Calls for Service Report & Department Update: Chief Leschke reported that there were 42 traffic citations issued, 15 written traffic warnings issued, and 5 municipal ordinance citations issued. He could not get a total of calls for service due to the County System being down for a few weeks. He also reported on the following:

- Officer Keberlein assisted the Waupaca PD with a Weapons Disturbance of shots fired.
- Officer Keberlein also involved in a pursuit with a local resident that was terminated at the Waupaca/Winnebago County Line. Offender was later arrested and faces 8 felony charges.
- > Sgt Strobusch responded to and located a local autistic child alone walking up the Hwy 10 exit ramp. He then reached out to Human services in support of assistance for the family to aid in safety devices for the home for the wellbeing of the child/family.
- ➤ Officer Vue observed and called out a wrong way driver on Hwy 10. Stop sticks were deployed by the Sheriff's Department and the operator was arrested for OWI.
- ➤ The CN Railroad Grant amount that SRO DeGrand applied for was \$9,095.16. The equipment for the Fatal Vison Educational Program has started to be shipped to City Hall.
- Officer DeGrand represented the Weyauwega PD at the Law Enforcement Torch Run for Special Olympics in Waupaca
- Sgt Strobusch is a certified Representative for Internet Crimes against Children (ICAC)
- ➤ He is also working closely with Caron Faulkner on ordinance violations and just cleaning up areas around the city.
